**MUNICIPAL ORDINANCE NO. 2020-071**

**SLAUGHTERHOUSE ADMINISTRATION ORDINANCE**

**BE IT ORDAINED** by the Sangguniang Bayan of Palanan, Isabela in session assembled, that:

**SECTION 01. PERMIT TO SLAUGHTER.** Before any animal is slaughtered for public consumption, a permit therefor shall be secured from the Municipal Health Officer or his duly authorized representative, preferably the Municipal Veterinarian or the Livestock Inspector, if any, who shall determine whether the manner or fowl is fit for consumption, upon payment to the Municipal Treasurer of the corresponding permit fee prescribed under existing tax ordinances. The permit shall bear the date and month of issue and the stamp of the Municipal Health Officer, as well as the page of the book in which the said permit number is entered and wherein the name of the permittee, the kind and sex of the animal to be slaughtered appears.

**SECTION 02. PROHIBITION.** Permit to slaughter shall not be granted nor the corresponding fee collected on animals condemned by the Municipal Health Officer or his duly authorized representative preferably a Veterinarian or the Livestock Inspector.

**SECTION 03. ADMINISTRATIVE PROVISIONS.**

- 1) The slaughter of any kind of animal intended for sale shall be done only in the municipal slaughterhouse designated as such by the Sanggunian. The slaughter of animals intended for home consumption may be done elsewhere, except large cattle which shall be slaughtered only in the Municipal Slaughterhouse. The animal slaughtered for home consumption shall not be sold or offered for sale.
- 2) Before the animal is slaughtered in the slaughterhouse, the slaughterhouse administrator or meat inspector thereof shall require for branded cattle, the production of the certificates of ownership and certificate of transfer showing the title in the name of person having custody of the animal. If he is not the original owner and there is no certificate of transfer made in his favor, one such certificate shall be secured from the Municipal Treasurer and the corresponding fee shall be collected therefor. For unbranded cattle that has not yet reached the age of branding, the Municipal Treasurer or his representative shall require such evidence as may be satisfactory to him regarding the ownership of the animals for which permit to slaughter has been requested. For unbranded cattle of the required age, the necessary certificate of ownership and/or transfer shall be issued, and the corresponding fees collected therefor before the slaughter permit is granted.

**SECTION 04. PROFESSIONALIZING THE MEAT BUTCHERING OPERATION.**

**a) General Requirements**

1. Butchers shall wear proper uniform and such uniform shall be designated and determined by the Office of the Local Chief Executive;
2. Butchers shall wear helmet, boots, gloves and mask during the butchering activity;
3. Cleaning and dressing of pigs, cows, carabaos and others in the floor is strictly prohibited and cleaning shall be in hanging position;

- 4. Meat of whatever kind shall be delivered to the market for selling purposes.
- 5. Butchers shall use stainless butchers knife and hook.

**SECTION 05. PENALTY.** Any person who violates the provision of this ordinance shall be punished by a fine of not more than Two Thousand Five Hundred Pesos (P2,500.00) or imprisonment of not more than six (6) months, or both fine and imprisonment, at the discretion of the Court.

**SECTION 06. SEPARABILITY CLAUSE.** If any section or provision of this Ordinance is declared unconstitutional or invalid by a competent court, other sections or provisions not affected hereof shall continue to be in full force and effect.

**SECTION 07. REPEALING CLAUSE.** All ordinances, resolutions, rules and regulations, which are inconsistent with or contrary to the provisions of this Ordinance are hereby repealed or modified accordingly.

**SECTION 08. EFFECTIVITY.** This Ordinance shall take effect upon its approval.
