MUNICIPAL ORDINANCE NO. 2020-034

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO.09-16, SERIES OF 2009, REQUIRING ALL HOUSEHOLD OWNERS OR OCCUPANTS, BUSINESS ESTABLISHMENT AND GOVERNMENT OFFICES TO OBSERVE THE "TAPAT KO LINIS KO" PROGRAM AND PRESCRIBING PENALTIES HEREOF

Be it ordained by the Sangguniang Bayan of Palanan in session assembled, that:

SECTION 1. TITLE. This Ordinance shall be known as "TAPAT KO LINIS KO ORDINANCE".

SECTION 2. DEFINITION. For the purpose of this Ordinance the following words, terms and phrases shall have the meaning given herein:

- (1) **WASTE** – garbage, refuse and other rubbish, which is not disposed of properly, tends to create a danger to public safety, diminished cleanliness and sanitation.
- (2) **HANGING AND DRYING** – colloquially known as "pagsasampay" of clothing, apparels and other materials which if not properly made, which result to visual clutters.
- (3) **IMMEDIATE SURROUNDINGS** – refers to frontage including up to the mid-span of the road, street alley or avenue (excluding highways and major thoroughfares) from the edge of the street gutter, sidewalks or residential houses, dwelling units, business/commercial establishments or offices whether public or private.
- (4) **CLUTTER** – to fill or cover with scattered or disordered things that impede movement or reduce effectiveness of the surroundings.
- (5) **AWNING**- a rooflike cover extending over or in front of a residence or establishment.

SECTION 3. COVERAGE. It shall be the responsibility of the owner and/or dweller, lessee, occupant of a residential or commercial establishment to maintain the cleanliness of the frontage or immediate surroundings of their residence or establishment.

SECTION 4. REGULATED ACTS. There is hereby required to all household owners, business establishments and government agencies to undertake and maintain cleanliness and good sanitation of their respective surroundings in order to maintain the "TAPAT KO LINIS KO" Program.

SECTION 5. TEMPORARY USE OF ROADS WHEN ALLOWED. The use of roads, streets, avenues, alleys, sidewalks, bridges, parks or other places on a temporary basis and for public purpose or use for a definite period only shall require a special permit from the Municipal Government.

SECTION 6. IMPLEMENTATION AND ENFORCEMENT. A technical working group shall be created to be composed of the following:

- a) All SB Members within Sectoral Representative
- b) OIC - Municipal Environment and Natural Resources Officer (MENRO)
- c) Sanitary Inspector
- d) Punong Barangays
- e) PNP Members
- f) Barangay Tanods

SECTION 7. PENAL PROVISION. Anyone who violates this ordinance shall upon conviction, be punished by a fine of:

- 1st Offense: Five Hundred Pesos (P500.00) or 8 hours for 1 day of community service;
- 2nd Offense: One Thousand Pesos (1,000) or 8 hours for 2 days of community service;
- 3rd Offense: One Thousand Five Hundred (1,500.00) or 8 hours for 3 days of community service.


It is understood that the fines shall accrue to the Municipal Treasury to form part of the General Fund of the Municipality.

SECTION 8. REPEALING CLAUSE. All previous Ordinance and Rules/Regulations, which are inconsistent with the provisions of this ordinance are hereby deemed, modified or repealed accordingly.

SECTION 9. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon its approval.


