MUNICIPAL ORDINANCE NO. 2020-046

ORDINANCE EXTENDING THE DEADLINE FOR THE PAYMENT OF REAL PROPERTY TAXES FOR THE (1<sup>ST</sup> AND 2<sup>ND</sup> QUARTER) FROM MARCH 31, 2020 TO JUNE 30, 2020; BUSINESS PERMIT FOR THE (2<sup>ND</sup> AND 3<sup>RD</sup> QUARTER) FROM APRIL 20, 2020 TO JULY 20, 2020; TRANSFER TAX ON REAL PROPERTY OWNERSHIP FROM THE DATE OF THE EXECUTION OF DEED FROM FEBRUARY 17, 2020 SHALL BE EXTENDED TO JUNE 30, 2020 AND RENEWAL OF TRICYCLE AND MOTORBOAT PERMIT FOR THE (2<sup>ND</sup> AND 3<sup>RD</sup> QUARTER) FROM APRIL 20, 2020 TO JULY 20, 2020, WITHOUT PENALTY IN THE MUNICIPALITY OF PALANAN, ISABELA.

WHEREAS, this August Body finds it necessary to enact an ordinance extending the deadline for the payment of the abovementioned taxes in this Municipality;

WHEREAS, the President of the Republic of the Philippines has issued Proclamation No. 929 placing the entire country under a State of Public Health Emergency for a period of six (6) months, unless lifted or extended as circumstances may warrant due to Corona Virus Disease (COVID-19);

WHEREAS, the declaration of the State of Public Health emergency capacitates government agencies and LGUs to immediately act to prevent loss of life, utilize appropriate resources to implement urgent and critical measures to contain or prevent the spread of COVID-19, mitigate its effects and impact to the community, and prevent serious disruption of the functioning of the government and the community;

WHEREAS, on March 11, 2020, the World Health Organization declared the Coronavirus Disease 2019 (COVID-19) as a pandemic due to the rapid increase of cases of infection worldwide;

WHEREAS, one of the precautionary measures stated in the above-mentioned memorandum is a strict home quarantine, which shall be observed in all households, movement shall be limited to accessing basic necessities, provision for foods and essential health services shall be regulated;

WHEREAS, the Municipality of Palanan, Isabela is landlocked and geographically isolated thereby making it vulnerable if entry of COVID-19 is not prevented, which would largely affect the whole populace;

NOW THEREFORE, Be it **ORDAINED** by the Sangguniang Bayan of Palanan, Isabela in session assembled that:

**SECTION 1. NATURE OF EXTENSION.** Payment of the following taxes, permits and renewal of franchises shall be extended on their respective schedule without penalty, to wit:

NATURE	ACTUAL DEADLINE	EXTENSION
a) Real Property Taxes	March 31, 2020 (for 1 <sup>st</sup> Quarter)	June 30, 2020 (1 <sup>st</sup> and 2 <sup>nd</sup> Quarter)
b) Business Permit	April 20, 2020 (for 1 <sup>st</sup> Quarter)	July 20, 2020 (2 <sup>nd</sup> and 3 <sup>rd</sup> Quarter)
c) Transfer Tax on Real Property	Within 30 days from transfer of ownership	June 30, 2020 or whichever is longer
d) Tricycle & Motorboat Permit	April 20, 2020 (for 2 <sup>nd</sup> and 3 <sup>rd</sup> Quarter)	July 20, 2020 (2 <sup>nd</sup> and 3 <sup>rd</sup> Quarter)

**SECTION 2. IMPLEMENTOR.** The Office of the Municipal Treasurer is hereby directed to implement Section 1 of this ordinance.

**SECTION 3. EFFECTIVITY.** This ordinance shall take effect upon its approval.
