MUNICIPAL ORDINANCE NO.2021-078

AN ORDINANCE BANNING THE LEADERS AND MEMBERS OF COMMUNIST PARTY OF THE PHILIPPINES-NATIONAL DEMOCRATIC FRONT – NEW PEOPLE’S ARMY (CPP-NDF-NPA) FROM POLITICAL ORGANIZING WORKS WITHIN THE TERRITORIAL JURISDICTION OF PALANAN, PROVINCE OF ISABELA

Be it ordained by the Sangguniang Bayan of Palanan, Isabela in session assembled that:

SECTION 1. SHORT TITLE. This Ordinance shall be known as the **“CPP-NDF-NPA Ban Ordinance”**.

SECTION 2. OBJECTIVE. The purpose of this Ordinance is to ensure that the Municipality be free from the influence of the CPP-NDF-NPA and their front organizations.

SECTION 3. COVERAGE. This ordinance shall apply to all residents and to all those who are visiting the Municipality.

SECTION 4. MANDATORY CLAUSE.

4.1. Any person known and proven to be belonging to or affiliated with the CPP-NDF-NPA is prohibited from entering the territorial jurisdiction of this Municipality.

4.2. All political organizing works undertaken by those groups and their front organizations are hereto declared illegal.

4.3. Political organizing works shall include but not limited to the following:


4.3.1. Conduct of seminars, conferences and public meetings that discuss issues with the end view of arousing public dissent against any duly instituted government authorities and its instrumentalities; and

4.3.2. Conduct of recruitment activities and such other undertakings so as to entice people to join their armed activities.


4.4. Hosting of their activities and of the CPP-NDF-NPA and their front organizations by any person or group of persons in the municipality are hereby made illegal and those caught doing so are to be considered as accessories and accomplices to said illegal activities.

4.5. The provision of any form of support to the CPP-NDF-NPA and their front organizations by any person or group of persons in the Municipality are likewise made illegal, and those caught doing so are to be considered as accomplices and accessories to said illegal activities.





SECTION 5. PENALTY CLAUSE. Any individual found to have violated the provisions of this Ordinance shall be fined of P2,500.00 or imprisonment of six (6) months or both fine and imprisonment at the discretion of the Court.


SECTION 6. FUNDING. An initial funding shall be allocated under the Peace and Order and Public Safety (POPS) Fund of this Municipality.

SECTION 7. SEPARABILITY CLAUSE. If any provision of this Ordinance found to be inconsistent with any law, other provisions or part/s thereof not so affected shall remain in full force and effect.

SECTION 8. REPEALING CLAUSE. All Ordinances, Rules and Regulations or parts thereof, in conflict with, or contrary to, the Provisions of this Ordinance not so affected herewith is hereby repealed or modified accordingly.

SECTION 9. EFFECTIVITY. This ordinance shall take effect immediately upon its approval.
