**MUNICIPAL ORDINANCE NO.2021-079**

**AN ORDINANCE REGULATING THE OPERATION OF BILLIARD OR POOL HALL IN THIS MUNICIPALITY AND PRESCRIBING PENALTIES THEREFOR**

**SECTION 01. REGULATED ACTS.** No person shall establish a billiard or pool within a radius of two hundred (200) meters from any religious or educational institutions and no person shall operate or maintain a billiard or pool hall without first securing a permit therefor from the Mayor and paying the corresponding tax or fee imposed under the Revenue Code of this Municipality.

**SECTION 02. RULES AND REGULATIONS.**

- 1) No permit shall be issued to any person to operate a billiard or pool hall with more than three (3) billiard tables.
- 2) No permit wager or bet shall be allowed by the operator of billiard or pool halls to be conducted therein by the players or other persons inside that establishment.
- 3) No children below eighteen (18) years old shall be allowed to play or view, watch or loiter within the vicinity of any billiard and pool halls;
- 4) Other necessary rules and regulations that are not inconsistent herewith may be issued by the Mayor for the proper implementation of this Ordinance.

**SECTION 03. PENALTY.** Any violation of the provisions of this Ordinance shall be punished by a fine of :

1 <sup>st</sup> Offense	: One Thousand Pesos (P 1,000.00);
2 <sup>nd</sup> Offense	: Two Thousand Pesos (P 2,000.00); and
3 <sup>rd</sup> Offense	: Two Thousand Five Hundred Pesos (P 2,500.00) and revocation of Mayor's Permit.

**SECTION 04. SEPARABILITY CLAUSE.** If any section or provision of this Ordinance is declared unconstitutional or invalid by a competent court, other sections or provisions not affected hereof shall continue to be in full force and effect.

**SECTION 05. REPEALING CLAUSE.** All ordinances, resolutions, rules and regulations, which are inconsistent with or contrary to the provisions of this Ordinance are hereby repealed or modified accordingly.

**SECTION 06. EFFECTIVITY.** This Ordinance shall take effect after fifteen (15) days posting and publication.
