**MUNICIPAL ORDINANCE NO. 2021-082**

**ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2019-11, SERIES OF 2019, FIXING THE PRICES OF BEEF AND CARABEEF IN THE MUNICIPALITY OF PALANAN, ISABELA AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF.**

Be it ordained by the Sangguniang Bayan of Palanan, Isabela duly assembled that:

**SECTION 1.** There is hereby fixed for stricter implementation the following prices of Beef and Carabeef within the Municipality, to wit:

**CARABEEF (Kalabaw)**

a) Flesh ( Laman, Lomo)	200.00/ kilo
b) Special (Papaitan)	200.00/kilo
c) Ribs & Bulalo	150.00/ kilo
d) Bones (Buto-buto)	150.00/ kilo
e) Ordinary Papaitan	150.00/kilo
f) Feet (Paa)	100.00/piece
g) Tail	160.00/kilo
h) Butt & Balls	120.00/kilo
i) Head (Ulo)	500.00/piece

**BEEF (Baka)**

a) Flesh ( Lomo, Laman)	270.00/kilo
b) Tail (Buntot), Butt & Balls	270.00/kilo
c) Special (Papaitan)	260.00/ kilo
d) Bulalo	220.00/ kilo
e) Ordinary (Papaitan)	220.00/ kilo
f) Bones ( Buto-buto)	220.00/kilo
g) Feet (Paa)	100.00/piece
h) Head (Ulo)	700.00/piece

**SECTION 2.** All butchered Carabaos and Cows shall only be sold and disposed of at the *Palanan Public Market*. Disposing and/or selling of Beef and Carabeef meat other than in the Public Market is strictly prohibited under this Ordinance.

**SECTION 3.** Any meat on sale in the market or by peddlers found to be unfit for human consumption shall be disposed of properly by the Municipal Veterinarian/Meat Inspector or his/her duly authorized representative.

**SECTION 4. PUBLIC BILLBOARDS, NOTICES IN THE BARANGAY.** Upon effectivity of this ordinance, the Engineering Office shall put up billboards in conspicuous places in the Municipality to notify the public of the prices and sanctions imposed in this Ordinance.

**SECTION 5. ENFORCEMENT.** *Members of the Palanan Police Force, Municipal Agriculturist Office, Barangay Officials, Barangay Tanods and Meat Inspector* are hereby ordered to help in the implementation of this Ordinance by apprehending violators and issue citation tickets.

**SECTION 6. FUNDING.** An initial funding to defray the expenses necessary for or incidental to the implementation of this Ordinance in the amount of *Fifty Thousand (Php 50,000.00) Pesos* shall be sourced-out from the MOOE of the *Offices of the Municipal Engineer and Municipal Agriculturist* and is hereby allocated every year thereafter.

**SECTION 7. PENALTY CLAUSE.** All violators will be penalized by a fine of:

- 1<sup>st</sup> Offense** : One Thousand Five Hundred Pesos (Php 1,500.00);
- 2<sup>nd</sup> Offense** : Two Thousand Pesos (Php 2,000.00) and confiscation of meat for sale ;and
- 3<sup>rd</sup> Offense** : Two Thousand Five Hundred Pesos (Php 2,500.00), confiscation of meat for sale and cancellation of Mayor's Permit .


**SECTION 8.** A Citation Ticket shall be issued to the persons liable for any violation of this Ordinance upon finding of the violation by duly authorized enforcers. When a Citation Ticket is issued to a violator, it shall be reported to the Barangay Government where the violation was committed to be recorded in the barangay logbook. Payment of fine shall be made at the Barangay Treasurer or Office of the Municipal Treasurer, as the case maybe.

**SECTION 9. SEPARABILITY CLAUSE.** If any provision of this Ordinance found to be inconsistent with any law, other provisions or part/s thereof not so affected shall remain in full force and effect.



**SECTION 11. EFFECTIVITY CLAUSE.** This Ordinance shall take effect upon approval.
