**MUNICIPAL ORDINANCE NO. 2021-083**

**ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2019-12, SERIES OF 2019, FIXING THE PRICE OF PORK AND POULTRY PRODUCTS IN THE MUNICIPALITY OF PALANAN, ISABELA AND PROVIDING PENALTIES FOR VIOLATIONS HEREOF.**

Be it ordained by the Sangguniang Bayan duly assembled that:

**SECTION 1.** There is hereby the fixing of prices of Pork and Poultry Products, to wit:

**PORK**

a) Special (Liver, Lomo, Heart, Kidney)	170.00/kilo
b) Maskara	160.00/ kilo
c) Prime Cuts	160.00/kilo
d) Straight Pata	150.00/kilo
e) Pata and Bones (Buto-Buto)	140.00/kilo
f) Head (Ulo)	140.00/kilo
g) Intestine (Bituka/Trapilya)	130.00/kilo

**POULTRY PRODUCTS**

a) Native Chicken (Live Weight/Male or Female)	150.00/kilo
b) Duck (Live Weight/Male or Female)	150.00/kilo
c) Turkey/Pabo) (Live Weight/Male or Female)	170.00/kilo

**SECTION 2.** All butchered pigs shall only be sold and disposed of at the Public Market. Disposing and/or selling of pork and poultry products other than in the Public Market is strictly prohibited under this Ordinance.

**SECTION 3. PUBLIC BILLBOARDS, NOTICES IN THE BARANGAY.** Upon effectivity of this Ordinance, the Engineering Office shall put up billboards in conspicuous places in the Municipality to notify the public of the prices and sanctions imposed in this Ordinance.

**SECTION 4. ENFORCEMENT.** *Members of the Palanan Police Force, Office of the Municipal Agriculturist, Barangay Officials, Barangay Tanods and Meat Inspector* are hereby ordered to help in the implementation of this Ordinance by apprehending violators and issue citation ticket.

**SECTION 5. FUNDING.** An initial funding to defray the expenses necessary for or incidental to the implementation of this Ordinance in the amount of *Fifty Thousand (P 50,000.00) Pesos* shall be sourced-out from the MOOE of the *Office of the Municipal Engineer and Municipal Agriculturist* and is hereby allocated every year thereafter.

**SECTION 6. PENALTY CLAUSE.** All violators will be penalized by a fine of:

- 1<sup>st</sup> Offense** : One Thousand Five Hundred Pesos (Php 1,500.00);
- 2<sup>nd</sup> Offense** : Two Thousand Pesos (Php 2,000.00) and confiscation of meat and poultry products for sale

;and

- 3<sup>rd</sup> Offense** : Two Thousand Five Hundred Pesos (Php 2,500.00), confiscation of meat and poultry products for sale and cancellation of Mayor's Permit .

**SECTION 7.** A Citation Ticket shall be issued to the persons liable for any violation of this Ordinance upon finding of the violation by duly authorized enforcers. When a Citation Ticket is issued to a violator, it shall be reported to the Barangay Government where the violation was committed to be recorded in the Barangay logbook. Payment of fine shall be made at the Barangay Treasurer or Office of the Municipal Treasurer, as the case maybe.

**SECTION 8. SEPARABILITY CLAUSE.** If any provision of this Ordinance found to be inconsistent with any law, other provisions or part/s thereof not so affected shall remain in full force and effect.

**SECTION 9. REPEALING CLAUSE.** All Ordinances, Rules and Regulations or parts thereof, in conflict with, or contrary to the provisions of this Ordinance not so affected herewith is hereby repealed or modified accordingly.


**SECTION 10. EFFECTIVITY CLAUSE.** This Ordinance shall take effect upon approval.


