MUNICIPAL ORDINANCE NO. 2021 -084

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2019-24, SERIES OF 2019, DESIGNATING A TEMPORARY PARKING AREA AS RELOCATION FOR DISPLACED PUBLIC UTILITY VEHICLES AND PRESCRIBING PENALTIES FOR VIOLATION THEREFOR

WHEREAS, it is hereby declared by the policy of the Local Government Unit to promote the general welfare, particularly the protection and security of the populace;

WHEREAS, the Local Government Code mandates the power of Local Government Unit to regulate all forms of transportation vehicles within its territorial jurisdiction to protect public interest and to promote the health, comfort, safety and welfare of the people;

WHEREAS, in order to maintain an orderly and proper parking areas, this Body formulates this ordinance to properly identify a designated municipal parking area for all types of public utility vehicles that will address the displacement issues in this municipality;

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF PALANAN, ISABELA IN SESSION ASSEMBLED THAT:

SECTION 1. TEMPORARY MUNICIPAL PARKING AREAS – *The portion of Camiguing Street, from Corner of Cauilan St., Eastward shall be designated as the temporary parking space and terminal passenger area intended for upstream barangays and the road beside the entrance of the Airport, between Corner of Cauilan St. at the end West Side of Cortez Street, shall be designated as temporary parking space and terminal passenger area intended for downstream barangays that shall serve as parking displacement for tricycle terminal affected by the road clearing operations and illegally parked vehicles in the Municipality.*

SECTION 2. DEFINITION OF TERMS

- a. **Transportation** – defined a movement of thing or person from one place to another.
- b. **Vehicle** – a thing equipment or utility used for transporting people or goods, especially on land, such as four wheel car, truck, single motorcycles, tricycles and the like used to express, embody or fulfill something.
- c. **Parking Area** – an area lot designated for parking cars, trucks, motorcycles, tricycles and the like.

SECTION 3. This ordinance shall be applicable only until such time that a permanent municipal parking area is identified.

SECTION 4. ENFORCEMENT. The Members of the Philippine National Police, Office of the Municipal Engineer, Barangay Officials and Tanods are hereby directed to ensure the implementation of this Ordinance.

SECTION 5. INFORMATION AND DISSEMINATION CAMPAIGN AND IMPLEMENTATION. *The Liga Ng Mga Barangay shall conduct an extensive information and dissemination campaign during their various fora to ensure full public awareness as well as implementation of this ordinance in their respective barangays.*

SECTION 6. PENALTY. Any person who violates this Ordinance shall be fined as follows:

- First Offense* - P 500.00;
- Second Offense* - P 700.00; and
- Third Offense* - P 1,000.00 and revocation of Mayor's Permit.

SECTION 7. All fines collected by the Municipal Treasurer or authorized representative shall accrue to the General Fund of the Local Government Unit.

SECTION 8. REPEALING CLAUSE. All ordinances, rules and regulations or part thereof in conflict with, or contrary to the provisions of this Ordinance not so affected herewith is hereby repealed or modified accordingly.

SECTION 9. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval.


