**MUNICIPAL ORDINANCE NO. 2021-073**

**AN ORDINANCE REGULATING THE SALE OF VOLATILE SUBSTANCE/SOLVENTS TO MINORS IN ALL BUSINESS ESTABLISHMENTS**

Be it **ORDAINED** by the Sangguniang Bayan of Palanan, Isabela in session assembled, that:

**SECTION 01. TITLE.** This Ordinance shall be known as the **"SELLING OF VOLATILE SUBSTANCE/SOLVENTS TO MINORS"** Ordinance.

**SECTION 02. SCOPE.** This Ordinance shall apply within the Territorial Jurisdiction of Palanan, Province of Isabela.

**SECTION 03. DEFINITION OF TERMS.**

**MINOR** – as use in this ordinance, shall be any person who is below eighteen (18) years of age.

**SOLVENT** – shall mean to have based contact cement like rugby, vulca seal, fed seal, elasto seal, thinner and other similar materials which can cause addiction.

**ESTABLISHMENT** – any hardware stores, sari-sari stores or any establishment engaged in selling goods and products to include solvents.

**LOGBOOK** - A record book kept by a store or hardware containing information of customer names, address and purposes for buying a solvent products.

**SECTION 04. REGULATORY ACTS.**

1. Owners of commercial stores or business establishments shall be prohibited to sell volatile substance/solvents such as "rugby" to minors.
2. Minors are prohibited to use rugby for addictive purposes.
3. Business establishments are required to maintain a logbook where the name, address and purpose of customer in buying the substance shall be recorded.

**SECTION 05. PENALTY CLAUSE.**

**SECTION 06. ENFORCEMENT.** The Members of the Philippine National Police, SK Officials and Barangay Tanods are hereby directed to ensure the widest dissemination and strict implementation of this Ordinance.

**SECTION 07. FUNDING.** An initial funding shall be allocated under the Peace and Order and Public Safety (POPS) Fund of this Municipality.

**SECTION 08. SEPARABILITY CLAUSE.** If any provision of this Ordinance found to be inconsistent with any law, other provisions or part/s thereof not so affected shall remain in full force and effect.

**SECTION 09. REPEALING CLAUSE.** All Ordinances, Rules and Regulations or parts thereof, in conflict with, or contrary to, the Provisions of this Ordinance not so affected herewith is hereby repealed or modified accordingly.

**SECTION 10. EFFECTIVITY.** This ordinance shall take effect immediately upon approval and after fifteen (15) days posting and publication.


