MUNICIPAL ORDINANCE NO. 2021 - 081

AN ORDINANCE BANNING THE TRANSPORT OF SWINE, HOGS AND MEAT PRODUCTS FOR PURPOSES OF SELLING OUTSIDE THE TERRITORIAL JURISDICTION OF PALANAN, ISABELA AND PROVIDING PENALTIES FOR VIOLATION THEREOF

WHEREAS, DILG Secretary, Eduardo M. Ano issued an Advisory dated September 25, 2019, enjoining all Local Government Units to implement measures to control the spread of African Swine Fever (ASF) due to the rapidly increasing number of ASF case in the Philippines affecting pigs and wild boars and to contain the outbreak in our areas of jurisdiction;

NOW THEREFORE, *Be it ORDAINED* by the Sangguniang Bayan of Palanan, Isabela, in session assembled that:

SECTION 1. REGULATED ACTS.

- 1.1. No person shall sell and/or transport swine, hogs and meat products to mainland Municipalities/Cities for purposes of selling hereof;
- 1.2. No person shall sell meat products beyond the price ceiling and selling other than in the Public Market;
- 1.3. Selling of live hog(s) for transport outside the territorial jurisdiction of this Municipality shall be strictly prohibited due to possible spread of African Swine Fever (ASF) and to avert the shortage of pork for food consumption of our local consumers.

SECTION 2. IMPLEMENTATION.

1) The *Office of the Municipal Agriculture* shall take all necessary measures to ensure the effective implementation and enforcement of the provisions of this Ordinance. Towards this end, it shall:

- a) Ensure the availability of meat products (i.e. pork) in the Public Market and was checked and/or inspected if it has a Veterinary Health Certificate;
- c) Monitor the transport swine, hogs, meat products and other related products brought outside the Municipality in all points of departure within our territorial jurisdiction.
- d) Monitor live hogs/large cattle slaughtered in the Municipal Slaughterhouse.

SECTION 3. EXEMPTION. The Municipal Agriculturist shall only issue necessary certificate/ permit to transport meat products brought outside the territorial jurisdiction of this municipality for purposes of personal food consumption.

MUNICIPAL ORDINANCE NO. 2021 – 081: AN ORDINANCE BANNING THE TRANSPORT OF SWINE, HOGS AND MEAT PRODUCTS FOR PURPOSES OF SELLING OUTSIDE THE TERRITORIAL JURISDICTION OF PALANAN, ISABELA AND PROVIDING PENALTIES FOR VIOLATION THEREOF

SECTION 3. IMPLEMENTERS. The Office of the Municipal Agriculture with the assistance of the Members of the Philippine National Police, Barangay Officials and Office of the Municipal Treasurer are hereby ordered to enforce the provisions of this Ordinance.

SECTION 4. PENALTY CLAUSE. Any person caught to violate the provisions of this ordinance shall be punished by a fine of One Thousand Five Hundred (P1,500.00) Pesos for the 1st Offense; Two Thousand (P2,000.00) Pesos and confiscation of meat products for the 2nd Offense; and Two Thousand Five Hundred (P2,500.00) Pesos, confiscation of meat products and cancellation of Mayor's Permit for the 3rd Offense.

SECTION 5. PAYMENT. Fines shall be paid to the Office of the Municipal Treasurer based on the citation ticket issued by the PNP or Office of the Municipal Agriculture and shall be recorded in the barangay logbook where the violation was committed.

SECTION 6. SEPARABILITY CLAUSE. If for any reason, any provision, portion or part of this Ordinance found to be inconsistent with any Law, other provisions or part/s thereof not so affected shall remain in full force and effect.

SECTION 7. REPEALING CLAUSE. All provision(s) of Municipal Ordinances, Orders or Regulations inconsistent herewith is hereby amended/modified/repealed accordingly.


SECTION 8. EFFECTIVITY AND AUTOMATIC DISSOLUTION CLAUSE. This Ordinance shall take effect immediately upon its approval and shall be deemed automatically dissolved and without effect until December 31, 2021.
