EXECUTIVE ORDER NO. 03 Series of 2021

AN ORDER DESIGNATING SEPARATE TEMPORARY PARKING SPACE CUM TERMINAL PASSENGER AREA FOR UPSTREAM AND DOWNSTREAM BARANGAYS AS PARKING DISPLACEMENT FOR TRICYCLES IN THE MUNICIPALITY OF PALANAN, ISABELA, THEREBY AMENDING EXECUTIVE ORDER NO. 24, SERIES OF 2019

WHEREAS, it is hereby declared by the policy of the Local Government Unit to promote the general welfare, particularly the protection and security of the populace;

WHEREAS, the Local Government Code mandates the power of Local Government Unit to regulate all forms of transportation vehicles within its territorial jurisdiction to protect public interest and to promote the health, comfort, safety and welfare of the people;

WHEREAS, in order to maintain an orderly and proper parking space, Executive Order No. 24, Series of 2019 was issued by the undersigned to designate a temporary parking area within the Municipality of Palanan, which likewise served as the Terminal Passenger Area for tricycles;

WHEREAS, with the continued implementation of Presidential Directive to clear Roads of Illegal Obstructions (Road Clearing 2.0), a clearing operation was held particularly Dela Peña Street where tricycles were illegally parked;

WHEREAS, as a result of the said road clearing operations, a dialogue was made between the tricycle operators and drivers and the MLGU, Liga ng mga Barangay and DILG-Palanan last January 27, 2021;

WHEREAS, a consensus was made during the said dialogue that there will be a separate temporary parking space/ terminal passenger area for upstream and downstream barangays;

NOW THEREFORE, I, ELIZABETH B. OCHOA, Municipal Mayor of Palanan, Isabela by virtue of powers vested in me by law, do hereby order:

SECTION 1. MUNICIPAL PARKING AREA / TERMINAL PASSENGER AREA OF TRICYCLES FOR UPSTREAM BARANGAYS. The portion of Camiguing Street, from Corner of Cauilan St., Eastward, shall be designated as the temporary parking space and terminal passenger area intended for *upstream barangays* of the municipality that shall serve as parking displacement for tricycle terminal affected by the road clearing operations, and illegally parked vehicles in the municipality;

SECTION 2. MUNICIPAL PARKING AREA / TERMINAL PASSENGER AREA OF TRICYCLES FOR DOWNSTREAM BARANGAYS. The road beside the entrance of the Airport, between Corner of Cauilan Street at the end and West Side of Cortez Street, shall be designated as the temporary parking space and terminal passenger area of the municipality intended for *downstream barangays* of the municipality that shall serves as parking displacement for tricycle terminal affected by the road clearing operations, and illegal parked vehicles in the municipality;

SECTION 3. This Executive Order shall be applicable only until such time that a permanent parking space and tricycle terminal passenger area is identified.

SECTION 4. REPEALING CLAUSE. All other orders, rules, regulations and issuance or parts thereof which are inconsistent with this Executive Order are hereby repealed or modified accordingly.

SECTION 5. EFFECTIVITY. This Executive Order shall take effect immediately, and shall remain in effect, unless otherwise amended, modified or revoked.
